

2. **THE** Trustees hereby declare that they or other Trustees hereof for the time being will hold upon trust the said sum of Rs.1,001/- (Rupees One thousand and one only) made over by the settlor to the trustees as aforesaid and all gifts, contributions, subscriptions, donations, bequests and other moneys or properties as and when the same shall be paid to or invested by or in the said trust and the moneys, investments and properties from time to time representing the same and apply the same for social spiritual moral religious, cultural, vocational and economic advancement of or for any other .....

general charitable and or religious purposes of public utility of the members of the SAHU SAMAJ and or public in general in the manner prescribing by the Trustees within the territories of India but not involving the carrying out any activities for profit or politics and do all or any of the followings :-

- a) To found, establish, maintain, finance, manage and or assist one or more buildings (s) for the use and welfare of the SAHU SAMAJ and or other communities and general public as the Trustees may deem fit, proper and necessary from time to time.
- b) To found, establish, maintain, manage, finance and/or assist schools and/or college for boys and/or girls, libraries, reading rooms etc. for the educational, cultural, social and moral uplift of the SAHU SAMAJ and/or public in general as the Trustees may deem fit, proper and necessary from time to time.
- c) To open, found, establish, manage, maintain, finance, assist and/or contribute to the maintenance and running of Charitable Dispensaries, Hospitals, Nursing Homes, Maternity Homes and/or institutions for the promotion of the health and general welfare of the SAHU SAMAJ and/or general public, as the Trustees may consider fit, proper and necessary from time to time.
- d) To found establish, manage and/or provide for scholarships, stipends and such other aid/s to and for deserving students and candidates of SAHU SAMAJ and/or general public for prosecuting their studies as the Trustees may deem fit, proper and necessary from time to time.
- e) To open, found, establish, maintain and/or manage one or more "BHANDARS" to assist the members of the SAHU SAMAJ and/or general public with articles for use on special occasions, like marriage and other such social and religious functions and ceremonies held in any family or on social basis either free or at reasonable or concessional rates as the Trustees may deem fit, proper and necessary from time to time, in relation to the different cases as it may arise.
- f) To assist in cash or in kind the poor, orphans, widows, physically mentally and/or economically handicapped persons of SAHU SAMAJ Community and/or public in general as the Trustees may deem fit, proper and necessary from time to time.
